CORNERSTONE HOUSING APPLICATION

Project Description

The Cornerstone Apartments are located at 1303 Gladstone Avenue. There are 4 self-contained, 3 bedroom units of market-based affordable family housing. The suits are located in a renovated 1912 heritage building and each suit is approximately 900sf. There are no dedicated parking spaces for the units and street parking is limited. No smoking permitted. One cat allowed. The units include heat and hot water. Hydro, cable, internet and telephone are not included. The building has shared coin operated laundry facilities.

Who is Eligible

- 3-6 person family groupings that include at least one parent and one dependent child
- Families with a combined family income ranging between \$39,000 \$57,000 annually

As the demand for these units is high, Fernwood NRG assesses each applicant's need for housing based on criteria which includes the applicant's income, current living situation, and personal and family requirements.

Purpose of this Form

This application form is designed to collect specific information from applicants in accordance with section 26 (c) of the Freedom of Information and Protection of Privacy Act (the FOI Act). Fernwood NRG will use this information to determine your eligibility for housing and the types of accommodation that best suit your needs.
